#### **Premises**

Focus of the thematic group: *Unlocking migrants' skills through VET* 

<u>Purpose of the meeting:</u> Identifying 5 key recommendations for policy makers based on the debate on the key points for discussion below.

<u>Context to consider:</u> This group is focused on one of the topic related to the four Commission and Erasmus+ programme's priorities: **social inclusion and diversity**. An economy that works for people is one of the Commission's priorities: when we talk about people, we refer to different segments of the population, such as job seekers, people with disabilities, women, migrants, youth and so on. In addition, the economic environment in which we live must ensure everyone is able to access the labour market without massive obstacles.

# **Key points for discussion**

- Identification of the main target groups (sub-groups: people with disabilities, mental diseases, unemployed, outsiders, etc.) involved in the achievement of specific objectives by focusing on specific aspects: age, country of origin, condition of arrival, personal condition, gender, necessity of training/upskilling/reskilling etc.
- 2. Identification of the **internal** and **external challenges** that interfere with the achievement of specific objectives.
- 3. Identification of the **internal** and **external factors** and, consequently, possible **opportunities**, **strengths** and **weaknesses** related to the achievement of the objectives.
